FOOD VENDORS

Please read carefully! These rules and regulations are part of the Festival contract and each participant should read, *sign* and adhere to these rules as listed below.

1. Booths will be assigned by the Festival Steering Committee. Priority will be given to those who register early, past participants, those with special needs, and/or YV Chamber Members.
2. Each vendor is responsible for collection of applicable tax.
3. All food vendor space sold in 20'x10' increments. *If cart tongues, tent stakes or guide wires, or awnings hang over the 10' x 20' foot area assigned, you will be asked to buy an additional space. Vendors are expected to stay within assigned space.*
4. Booth vendors must supply own tents, tables, chairs, display racks, all weather gear and required fire extinguishers. Tents must be anchored and/or secured.
5. **Vendors MUST dispose of used cooking grease/oil properly. (more information provided in letter)**
6. **Vendor MUST NOT leave any grease or food on the street or will be required to come back the next day to clean it.**
7. The Festival will be held rain or shine.
8. The booth fee is only refundable if the Steering Committee should judge your application not acceptable.
9. **All vendors must name Yadkin Valley Pumpkin Festival on a certificate of Insurance for the event. Please contact your insurance carrier for details.**
10. The Festival Steering Committee shall have sole discretion to require the removal of work or entire booths that violate any Festival, State or Local rules.
11. The Festival Steering Committee reserves the right to approve or reject any application for any reason.
12. The Festival and its sponsors are not liable for injury or theft occurring during the event. NO PETS!
13. **No vehicles will be allowed on the street after 8AM and before 4PM.**
14. **NO Breakdown before 4:00PM unless for bad weather. .**

SET UP TIME: Saturday, September 26, 2026 ~ 6:30 to 8:00 A.M.

Festival Hours ~ 9:00A.M. to 4:00 P.M.

Please sign and return with your application – another copy will be sent to you along with your confirmation letter closer to festival date.

- **Certificate of Insurance naming the Yadkin Valley Chamber of Commerce as additional insured MUST accompany application.**

Total entry fee must accompany this application. Make check payable to: YADKIN VALLEY CHAMBER OF COMMERCE. If your application is not selected, your money will be returned.
